ORDER APPROVING TARIFF SHEET

Issue Date: January 5, 2011 Effective Date: January 5, 2011

In File No. GR-2007-0003, the Commission approved an agreement concerning Union Electric Company d/b/a Ameren Missouri's natural gas energy efficiency programs. On October 21, 2010, in File No. GT-2011-0130, the company filed proposed tariffs to implement revisions to the program. The Commission, upon a motion filed by the Office of the Public Counsel, suspended the proposed revisions and moved the case toward an evidentiary hearing set for December 30. Upon representation by the parties that a settlement was reached, the Commission, on December 28, suspended the procedural schedule. Concurrently, the parties have made progress with respect to the program in Ameren Missouri's general rate case, File No. GR-2010-0363.

In this case, File No. GT-2011-0212, Ameren Missouri filed a proposed tariff sheet on December 31 requesting to continue the program until February 28, 2011, as it is currently delineated in the company's tariff. The tariff sheet has an effective date of January 30. Ameren Missouri informs the Commission that the program expired on December 31 and therefore requests that the Commission grant expedited approval of the

tariff sheet to reduce the gap in the program; such gap being that between expiration of the program on December 31 and the effective date of a Commission order approving the proposed tariff sheet.

Ameren Missouri represents that Staff Counsel does not object to the motion for immediate approval of the tariff sheet. Additionally, Public Counsel and the Missouri Department of Natural Resources filed responses supporting expedited approval of the tariff sheet.

The Commission has reviewed the proposed tariff sheet and notes that it mirrors the tariff sheet which is already in effect. Further, the Commission recognizes that the parties agree to an expedited approval of the tariff sheet and that expedited approval of the tariff sheet will reduce the gap in implementation of the program. The Commission finds good cause for the sheet to be effective on less than 30 days' notice and will issue an order approving the sheet as requested.

THE COMMISSION ORDERS THAT:

- 1. Union Electric Company d/b/a Ameren Missouri's motion for expedited treatment of the proposed tariff sheet is granted.
- 2. The following proposed tariff sheet, Tariff No. JG-2011-0340, is approved to become effective on January 5, 2011:

P.S.C. Mo. No. 2 3rd Revised Sheet No. 83, Cancelling 2nd Revised Sheet No. 83

- 3. This case shall become effective on January 5, 2011.
- 4. This case shall be closed on January 6, 2011.
