Enclosed herewith for filing with the Missouri Public Service Commission is a revised tariff sheet, P.S.C. MO. No. 5 Consolidated, Second Revised Sheet No. 28-d, which is applicable to both divisions of Laclede Gas Company ("Company"). This revised tariff sheet, which has an issue date of October 8, 2008 and an effective date of November 8, 2008, is being filed pursuant to paragraph 3(c) of the Unanimous Stipulation and Agreement ("S&A") approved by the Commission in Case No. GR-2007-0208. Such paragraph provides that beginning with the new Purchased Gas Adjustment ("PGA") rates that become effective in November 2008, the Company shall use the throughput determinants established in the settlement of such rate proceeding for purposes of calculation of the Company's Current PGA factors. Sheet No. 28-d reflects such new standard determinants. The Company has determined that no other tariff sheet revisions are necessary to effectuate the PGA rate changes contemplated by this paragraph of the S&A.
