**JOINT MOTION FOR EXTENSION OF THE EFFECTIVE DATE OF THE CONSENT
ORDER AND DISMISSAL. AND MOTION FOR EXPEDITED TREATMENT**

COME NOW Kansas City Power & Light Company ("KCP&L"), the Staff of the Missouri Public Service Commission ("Staff"), Office of the Public Counsel ("Public Counsel"), and Midwest Energy Consumers Group ("MECG")(collectively "Signatories") and respectfully submit their Joint Motion To Extend The Effective Date of the Consent Order And Dismissal issued on June 26, 2013. In support of this motion, the Signatories state as follows:

1. On June 26, 2013, the Commission issued its Consent Order And Dismissal with an effective date of July 2, 2013.

2. The Signatories request that the Commission extend the effective date of the Consent Order And Dismissal until July 16, 2013, so that the parties can continue to discuss the implications of the Consent Order and Dismissal. Otherwise, some of the Signatories will find it necessary to file pleadings prior to the existing effective date before discussions of the implications have been completed.

3. Pursuant to 4 CSR 240-2.080.(16), the Signatories request expedited treatment of this Motion. The Signatories respectfully request approval of this motion at the Agenda Meeting on Monday, July 1, 2013 so that the effective date of the Consent Order And Dismissal can be extended prior to its current effective date of July 2, 2013. There will be no negative effect on the Company's customers or the general public if the Commission acts in an expeditious manner as requested herein.

This pleading was filed as soon as it could have been, since the Consent Order And Dismissal was issued on June 26, 2013.

WHEREFORE, for the foregoing reasons, the Signatories respectfully request that the Commission extend the effective date of the Consent Order And Dismissal from July 2, 2013 until July 16, 2013.
