1. In accordance with the Commission's Order Amending Procedural Schedule issued March 16, 2006, the existing schedule in this matter provides:

April 13, 2006	Statement of Positions, List of Witnesses, Order of Witnesses
April 20-21, 2006	Hearing

By the Commission's Order issued March 31, 2006, the Commission confirmed that the April 20-21, 2006 dates are reserved for an evidentiary hearing or stipulation hearing, and further ordered that "[a]ny stipulation must be presented, written and signed by the parties, on or before the hearing date."

2. The Parties are continuing discussions to reach agreement and submit a Stipulation in this matter and, to that end, the Parties respectfully request that the April 6, 2006 procedural date be extended at this time. If no agreement is reached, the Parties

commit to filing a List of Issues no later than April 11, 2006. The subsequent events in the existing procedural schedule would remain the same.

3. The Commission's rule at 4 CSR 240-2.050(3) provides that the Commission may order a period enlarged before the expiration of that period if an act is required or allowed to be done by order of the Commission.
