JOINT MEMORANDUM

Come now GTE Arkansas Incorporated ("GTE") and CenturyTel of Northwest Arkansas LLC ("CenturyTel") (also collectively referred to as "Joint Applicants") and for their Joint Memorandum state to the Missouri Public Service Commission ("Commission") as follows:

- 1. On June 22, 2000, the Commission issued its Order Approving Transfer of Assets and Granting Certificate of Service Authority authorizing GTE to transfer certain assets located in Missouri to Century Tel and granting a certificate of service authority to provide service in two Missouri exchanges, Pea Ridge and Seligman.
- 2. In this same Order, the Commission approved tariff sheets with an effective date of July 1, 2000. GTE was directed to file proposed tariff sheets to remove these two exchanges from its tariff.
- 3. On June 30, counsel for Century Tel filed a letter with the Commission stating that due to a delay in receiving the necessary Federal Communications Commission ("FCC") approvals and waivers, the closing of the transaction had been delayed. Therefore, CenturyTel voluntarily extended the effective date of the tariff to August 1, 2000.



- 4. On October 11, 2000, the Commission issued an Order Directing Filing in which it directed the parties to file a status update with the Commission no later than October 31 regarding the transactions authorized in the Commission's Order.
- 5. Joint Applicants hereby state to the Commission that prior to July 31, 2000, the FCC study area waiver was obtained and the transaction authorized by the Commission was closed on July 31, 2000. Century Tel began providing service in the two exchanges on August 1, 2000, in accordance with its tariff previously approved by the Commission effective August 1 as voluntarily extended. On that same date, GTE ceased to provide service in the two exchanges.

WHEREFORE, Joint Applicants respectfully request that the Commission accept this Joint Memorandum as a status report on the transaction authorized in the Commission's June 22 Order.
