On August 8, 2017, Gail and Shelia Dinwiddie ("Complainants") filed a complaint with the Missouri Public Service Commission ("Commission") against Southwestern Bell Telephone Company d/b/a AT&T Missouri ("Respondent").

On September 7, 2017, Respondent filed *AT&T Missouri's Answer and Motion to Dismiss*. Respondent states the Commission must dismiss the complaint because it alleges claims outside the Commission's jurisdiction. Respondent relies on 386.330(4) RSMo, which states in part: "Notwithstanding the power of the commission over telecommunications companies, the commission shall not have jurisdiction over complaints concerning yellow page listings and advertisements . . ."

Respondent also asserts that the complaint must be dismissed because Respondent is the incorrect party and does not "publish or engage in the directory advertising business."

THE COMMISSION ORDERS THAT:

1. Gail and Shelia Dinwiddie shall respond no later than September 17, 2017.
2. This order shall be effective when issued.
