ORDER APPROVING TARIFF SHEET AND GRANTING MOTION FOR EXPEDITED TREATMENT

Issue Date: January 26, 2006 Effective Date: January 29, 2006

Syllabus: This order approves on an expedited basis the tariff sheet filed in compliance with a Commission order by Missouri Gas Energy, a division of Southern Union Company.

On January 19, 2006, the Commission issued an order that authorized MGE to file a tariff to impose an infrastructure system replacement surcharge (ISRS). That order will become effective on January 29, 2006. On January 20, 2006, MGE filed a revised tariff sheet in compliance with the Commission's order, and filed a motion requesting expedited treatment of that tariff sheet. MGE requests that the revised tariff sheet become effective on January 29, 2006.

As support for its motion, MGE states that the ISRS is authorized by Sections 393.1009, 393.1012, and 393.1015, RSMo, and Commission Rule 4 CSR 240-3.265. MGE further states that the granting of expedited treatment will afford it the rate relief in a timely manner as contemplated by the statute. Because the Commission has previously

examined the ISRS request and authorized the filing of this tariff, MGE alleges that there will be no negative effect on its customers or the general public.

The Commission directed that any responses to MGE's motion be filed no later than January 24, 2006. The Staff of the Missouri Public Service Commission reviewed the tariff filing and filed its recommendation on January 24, 2006. Staff states that it has reviewed the tariff and finds it to comply with the Commission's order. In addition, Staff also believes good cause exists to approve this tariff on an expedited basis because accelerated consideration of ISRS tariffs is contemplated in the statute. No other responses were filed.

The Commission has reviewed MGE's tariff filing and Staff's recommendation. Based on these filings, the Commission finds that the tariff sheet shall be approved as ordered below. Furthermore, because the statute sets out an abbreviated procedure for the approval of an ISRS, the Commission finds that good cause exists to approve these tariffs on an expedited basis.

IT IS THEREFORE ORDERED:

- That Missouri Gas Energy, a division of Southern Union Company's Motion for Expedited Treatment is granted.
- 2. That Tariff No. YG-2006-0559, submitted on January 20, 2006, is hereby approved for service to be rendered on or after January 29, 2006. The tariff sheet approved is:
