**ORDER DIRECTING STATUS UPDATE**

On July 1, 2021, the Staff filed a Gas Incident Report (“Report”) in this case describing a July 1, 2020, incident in which a contractor damaged a 12-inch gas main owned by Spire Missouri West (“Spire”). Staff’s Report also addressed Spire’s previous damage prevention activities and prescribing certain remedial action. Spire filed its response to the Report on September 13, 2021, requesting that the Commission limit the scope of required action to certain items.

On September 28, 2021, Staff filed its complaint case against Spire, File No. GC-2022-0087, based on the issues brought to light in this case. After filing its complaint case, Staff filed its response to Spire’s request in this case on October 21, 2021, stating that the parties were engaged in ongoing discussions aimed at resolving disagreements. On February 2, 2022, an *Order Approving Stipulation and Agreement* was issued in the complaint case (GC-2022-0087), resolving all issues, however this case remains. It is unknown by the Commission whether additional action is anticipated by the parties in this case.

The Commission will direct Staff to provide a status report
