On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. At that time, the Commission ordered Staff to file a progress report regarding its investigation by February 28, 2022.

Staff timely filed its progress report on February 28. Staff explains that its investigation is proceeding and asks that it be directed to file either a report regarding its investigation, or a further progress report by no later than June 24, 2022. The Commission will order Staff to file a further report.
