On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. At that time, the Commission ordered Staff to file a progress report regarding its investigation by February 28, 2022. Staff timely filed its initial progress report, and the Commission directed Staff to file a further progress report by June 24, 2022.

Staff timely filed its second progress report on June 23, 2022. Staff explains that its investigation is proceeding and asks that it be directed to file either a report regarding its investigation, or a further progress report by no later than October 28, 2022. The Commission will order Staff to file a further report.

THE COMMISSION ORDERS THAT:

- 1. Staff shall file either a report regarding its investigation, or a report on the investigation's progress, no later than October 28, 2022.
 - 2. This order shall be effective when issued.
