Subject: Staff Recommendation to Approve Tariff Sheets Filed to Clarify AmerenUE's Daily

Balancing and Cash-Out of Customer Owned Gas Tariff and on a Motion for Expedited

Treatment

On March 23, 2006, Union Electric Company d/b/a AmerenUE (UE or Company) filed a tariff sheet proposing to clarify UE's daily balancing and cash-out of customer-owned gas provisions of its Natural Gas Transportation Service tariff. On March 23, 2006, UE filed a motion for expedited treatment to propose an effective date of March 31, 2006, which is less than thirty (30) days notice.

UE filed this change to clarify the charges for imbalances of customer owned gas. This allows school entities to continue to cash-out on a monthly basis instead of requiring school entities to cash-out on a daily basis. This proposal does not provide additional margin revenues to UE, but revenues collected under this proposal will flow back to sales service customers through the Actual Cost Adjustment mechanism of the Purchased Gas Adjustment.

The Commission's Energy Department Tariffs/Rate Design Staff (Staff) has reviewed this filing and UE's motion for expedited treatment and has determined that the tariff sheet has been filed in compliance with Commission rules and regulations and Staff has no objection to the proposed changes to UE's Natural Gas Transportation Service. The Staff has verified that the Company has filed its annual report and is not delinquent on any assessment. Staff has reviewed this filing and is not aware of any issue currently pending before the Commission that affects, or is affected by, this filing.

Staff therefore recommends of the following tariff sheet, as filed on March 23, 2006 with an effective date of March 31, 2006:
