JOINT RESPONSE TO THE COMMISSION'S ORDER DIRECTING FILING

COMES NOW Spire Missouri Inc. ("Spire Missouri" or "Company"), on behalf of Staff of the Missouri Public Service Commission ("Commission") and the Office of the Public Counsel ("OPC") and files this Joint Response to the Commission's Order Directing Filing and states as follows:

1. On December 22, 2021, Spire Missouri filed its Verified Application for Approval of Financing Authority, Request for Waiver from 60-Day Notice Rule and Motion for Expedited Treatment.

On January 31, 2022, the Staff of the Missouri Public Service Commission
("Staff") filed its Recommendation with conditions.

3. On February 10, 2022, both OPC and Spire Missouri filed Reponses to Staff's Recommendation, with OPC proposing additional conditions.

4. On February 23, 2022, the Commission issued an Order Approving Application for Financing Authority.

5. The Order includes the following condition: (1) The Company is authorized to issue conventional term loans, first mortgage bonds, unsecured debt, preferred stock and common stock in an aggregate amount not to exceed \$800 million at any time, or from time to time, through December 31, 2024, provided that the Company shall not be authorized to use any portion of the \$800 million for any purpose other than for the exclusive benefit of Spire Missouri's regulated operations, as such purposes are specified in Section 393.200.

However, if the Company plans to issue anything other than senior secured debt (registered or privately-placed), it shall file notification with the Commission thirty (30) days in advance of doing so.
