**AMEREN MISSOURI PRODUCTION OF DOCUMENTS TO PRESIDING OFFICER  
PURSUANT TO 4 CSR 240-2.130(16)**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), and as instructed at the evidentiary hearing held on this Complaint on April 20, 2015, produces additional documents in this Complaint as follows:

1. An evidentiary hearing in this Complaint was conducted on April 20, 2015.
2. During the evidentiary hearing, Complainant handed Ameren Missouri witness, Cathy Hart, a document, asked her to identify it, and asked that the document be admitted into evidence.
3. Ms. Hart reviewed the document and testified to the effect that the document appeared to be incomplete (missing a page or pages) and for that reason she was unable to identify it as a true and accurate copy of a document that she had previously provided to Complainant.
4. The Presiding Officer did not admit the document into evidence, but rather instructed Ameren Missouri that if its records included a complete copy of the document, the Company should submit such document through EFIS, promptly after the hearing.
5. The Company has searched its records and has located two documents that relate to the partial document that Complainant sought to admit into evidence.
6. The first document is a letter dated March 17, 2011, from Cathy Hart to Complainant, which Ms. Hart drafted in Word format, printed on Ameren Missouri letterhead paper, and mailed to Complainant at a Quincy, Illinois address. The letter was returned to

Ameren Missouri by the U.S. Post Office. The letter is attached hereto as Exhibit A. A copy of the envelope, evidencing the return to sender stamp, is attached hereto as Exhibit B.

7. After the first letter was returned, Ms. Hart updated the date of the letter to March 28, 2011, and resent it to Complainant's Milton, Iowa address. Ms. Hart printed the letter on Ameren Missouri letterhead paper for mailing, but retained in her files only an electronic copy, in Word format, such that the electronic copy does not include Ameren Missouri's letterhead. Ms. Hart's copy of the second letter is attached hereto as Exhibit C.

Wherefore, as directed by the Presiding Officer, Ameren Missouri respectfully submits Exhibits A, B and C.
