## STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and, for its recommendation to approve tariff sheet, respectfully states:

- 1. In the attached Memorandum (Appendix A) the Staff recommends the Commission approve the tariff sheet KCP&L Greater Missouri Operations Company (GMO) filed on January 14, 2011, to become effective March 1, 2011.
- 2. On January 14, 2011, GMO filed its tariff sheet to make a quarterly cost adjustment required by GMO's Quarterly Cost Adjustment Rider, which the Commission approved in Case No. HR-2005-0450, and modified in Case HR-2010-0028. The Quarterly Cost Adjustment Rider requires quarterly rate adjustments, with not more frequent than annual true-ups.
- 3. Staff reviewed the tariff sheet and is of the opinion that the quarterly cost adjustment for the fourth quarter of 2010 has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff and complies with the Commission's Order in HR-2009-0092.
- 4. The Staff recommends the Commission issue an order approving the tariff sheet to become effective March 1, 2011, as requested by GMO, or allow it to go into effect by operation of law.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission approve to become effective March 1, 2011, or allow to go into effect by operation of law, the Tariff Sheet GMO filed on January 14, 2011, to wit:
