ORDER APPROVING TARIFF SHEET

Issue Date: November 17, 2010

Effective Date: December 1, 2010

On October 14, 2010, KCP&L Greater Missouri Operations Company filed a tariff sheet containing a quarterly cost adjustment for fuel cost changes in the third quarter of 2010. The tariff sheet was required to be filed by GMO's Quarterly Cost Adjustment Rider as approved by the Commission in File No. HR-2005-0450 and amended in File Nos. HR-2009-0092 and HR-2010-0028, for steam service on and after July 1, 2009. GMO's tariff sheet has a proposed effective date of December 1, 2010.

The Staff of the Commission filed a recommendation on November 10, 2010. Staff has reviewed the tariff and believes GMO's calculations for the third quarter of 2010 are correct and in accordance with the provisions of GMO's Quarterly Cost Adjustment Rider. Staff recommends that the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. No other responses to the tariff were filed.

The Commission has reviewed GMO's tariff sheet and Staff's recommendation. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission's previous orders and GMO's current tariff provisions. The Commission approves the tariff sheet as ordered below.

THE COMMISSION ORDERS THAT:

1. Tariff No. YH-2011-0203, submitted on October 14, 2010, is approved pursuant to the terms of the Stipulation and Agreement approved in File No. HR-2005-0450, and modified or amended in File Nos. HR-2009-0092 and HR-2010-0028, for steam service rendered on or after December 1, 2010. The tariff sheet approved is:
