## ORDER SETTING DEADLINE FOR INTERVENTION

Issue Date: July 6, 2023

Effective Date: July 6, 2023

The tariff of Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) provides EMW with a rate adjustment mechanism to reflect changes in fuel costs for its steam systems, permitting quarterly adjustments identified as Quarterly Cost Adjustments (QCA). A provision for prudence reviews of EMW's implementation of the QCA is included in the tariff.

Pursuant to the terms of the tariff, on March 15, 2023, the Staff of the Commission (Staff) notified EMW of its intent to conduct a full prudence review of the costs and revenues associated with EMW's steam operations for the period of January 1, 2022 through December 31, 2022. Staff subsequently filed its *Notice of Start of Prudence Review*, in which it stated its intent to complete the full prudence review no later than August 13, 2023 – 225 days after the end of the year reviewed, as specified in the tariff.

The Commission will set a deadline for intervention.

### THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than August 4, 2023.
2. This order is effective when issued.
