STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On October 3, 2008, Spectra Communications Group, LLC, d/b/a Spectra, filed its Application for Competitive Classification pursuant to Section 392.245.5, RSMo, as amended by H.B. 1779. In its application, Spectra requests that the Commission classify all of Spectra's business services, other than exchange access service, in the following exchanges: (1) Aurora, (2) Brunswick, (3) Cameron, (4) Everton, (5) Golden City, (6) Greenfield, (7) Lawson, (8) Mt. Vernon, (9) Sarcoxie, and (10) Savannah. Concurrent with its application, Spectra filed a tariff amendment with an effective date of November 2, 2008.

2. As amended, Section 392.245.5 RSMo. (2008) states, in part:

5. Each telecommunications service offered to business customers, other than exchange access service, of an incumbent local exchange telecommunications company regulated under this section shall be classified as competitive in any exchange in which at least two non-affiliated entities in addition to the incumbent local exchange company are providing basic local telecommunications service to business **or residential** customers within the exchange. (emphasis added).

3. In the attached Memorandum, labeled Appendix A, the Staff summarizes its review and recommends approval.

WHEREFORE, the Staff recommends that the Commission approve Spectra's application and revised tariff sheets effective November 2, 2008.

Subject: Staff Recommendation to Approve Tariff Sheets Designating Business Telephone Service in Certain Telephone Exchange Areas to be Deemed Competitive

Date: October 20, 2008

On October 3, 2008 Spectra Communications Group, LLC d/b/a CenturyTel (Spectra) filed an application to receive competitive classification for business telephone service in the Aurora, Brunswick, Cameron, Everton, Golden City, Greenfield, Lawson, Mt. Vernon, Sarcoxie, and Savannah telephone exchange areas. Spectra's filing is made pursuant to Subsection 392.245.5 RSMo, which permits Incumbent Local Exchange Carriers to receive competitive classification for business service when residential service was previously found to be competitive. According to the most recent MoPSC annual reports, these exchange areas continue to show the presence of at least one qualifying competitor and the Staff is unaware of any wireless provider withdrawing from any exchange.

The Staff has no objections to the company's filing and recommends the following tariff sheets be permitted to take effect on November 2, 2008.
