## ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE AND ESTABLISHING TIME FOR FILING RECOMMENDATIONS

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filling of requests to intervene and for the filling of recommendations.

On December 4, 2012, Southwestern Bell Telephone Company, d/b/a AT&T Missouri, filed an application and Motion for Expedited Treatment under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), NeuStar, Inc., to withhold certain numbering resources from AT&T Missouri. The numbering resources AT&T Missouri requested consist of one thousands-block from with two hundred (200) consecutive numbers can be drawn within (1) the 314 NPA, (2) the St. Louis rate center, and (3) the XXXX range of 3500-3599 and 3600-3699. The numbering resources are

needed in order to meet the needs of First Bank's implementation of its disaster recovery configuration requirements.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

## THE COMMISSION ORDERS THAT:

- 1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.
- 2. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than December 14, 2012, with:

- 3. The Staff of the Commission shall file a recommendation regarding the application of AT&T Missouri or shall file a status report indicating when a recommendation will be filed, no later than December 14, 2012.
- 4. Any other party that wishes to file a recommendation regarding the application of AT&T Missouri, shall do so no later than December 14, 2012, and shall file its recommendation simultaneously with its application to intervene.
  - 5. This order shall become effective December 4, 2012.
