Sprint is making this filing to reduce its intrastate access rates and to make a corresponding, revenue-neutral rate increase to basic local telecommunications services, pursuant to subsection 8 and 9 of RSMo 392.245. Specifically, Sprint proposes to decrease its carrier common line access charge and to offset the revenue loss by increasing the rates for basic local telecommunications services by \$1.50 per month. Sprint became subject to the price cap provisions of the Act on August 29, 1999, and this proposed rate rebalance is the fourth and final rebalance allowed by law.

As determined by the Commission in Case No. TR-2002-251¹, Sprint's monthly rates for basic local telecommunication services remain below long run incremental cost while its access rates remain above cost. Thus, Sprint has met the mathematical test defined by The Act for rate rebalancing. The proposed effective date for these changes is December 18, 2003 which is the anniversary date of Sprint's third rate rebalance² in December 2002.

In prior years, Sprint simultaneously filed its proposed changes for all three aspects of the Price Cap Statute: (1) the rate rebalance³, (2) the Consumer Price Index adjustments⁴, and (3) the non-basic service price changes⁵. For its 2003 changes, Sprint has bifurcated the filing process to provide the Commission,

its Staff, and the Office of Public Counsel ample time to review the fourth and final rate rebalance and to be consistent with statutory timeframes.

Another benefit of Sprint's advanced filing process, is that the outcome of the proposed rate rebalance will be set prior to Sprint's mandated filing of the annual Consumer Price Index and non-basic services adjustments, simplifying the calculation of Sprint's Consumer Price Index adjustments. Assuming the Commission takes a full 45 days to reach a decision in this case, a final order should be issued on or around October 13, 2003. Sprint anticipates filing the annual Consumer Price Index adjustment to its basic service prices along with any non-basic service price changes no later than November 3, 2003 which is 45 days prior to effective date of December 18. Customer notification for all changes, including the attached rebalance, will be made simultaneously to avoid customer confusion that may arise from multiple notifications and will be made at least 30 days prior to December 18.


Approval of Sprint's proposed rate rebalance will complete a four year process of moving rates for access services and basic local services closer to their costs. The legislature enacted the four years of rate rebalancing to promote a competitive telecommunication environment by removing at least a portion of the implicit subsidies contained in long distance and access charges. The legislators understood that implicit subsidies discourage competition by artificially keeping toll rates high and basic local rates low.

Four years of rate rebalancing produces no new revenue for ILECs like Sprint. The Price Cap Statute requires each of Sprint's four allowed annual rebalances to be revenue-neutral. In fact, upon starting the rate rebalancing process, Sprint was required to reduce its intrastate long distance rates by ten percent. The legislators provided the rate rebalancing to benefit Missouri consumers by removing as much implicit subsidies as possible from long distance and access rates and, thus, encourage competition.

Sprint respectfully requests these proposed tariff changes be accepted and approved by October 13, 2003.
