COMES NOW, Sprint Missouri, Inc. ("Sprint") and Reitz Rentals, Inc., d/b/a SouthWest TeleConnect together referred to as Joint Applicants) and hereby file this Joint Application for Approval of Interconnection and Resale Agreement (the Agreement) under the Telecommunications Act of 1996 (the Federal Act) and in support show the following:

**I. INTERCONNECTION AND RESALE AGREEMENT REACHED**

Joint Applicants present to the Missouri Public Service Commission (Commission) for approval an agreement (attached as Attachment I) negotiated and executed pursuant to the terms of the Federal Act. After weeks of intensive good faith negotiations to address all of the complex issues involved in such an agreement, the parties executed on November 15, 1999 the attached Interconnection and Resale Agreement between Sprint and Reitz Rentals, Inc., d/b/a SouthWest TeleConnect. There are no outstanding issues related to resale or interconnection between Sprint and Reitz Rentals, Inc., d/b/a SouthWest TeleConnect that need the assistance of mediation or arbitration.

## II. REQUEST FOR APPROVAL

Sprint and Reitz Rentals, Inc., d/b/a SouthWest TeleConnect seek the Commission's approval of the Agreement, consistent with the provisions of the Federal Act. Both parties believe that the implementation of this Agreement complies fully with Section 252(e) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, provides interconnectivity, and increases customer choices for telecommunications services.

Sprint and Reitz Rentals, Inc., d/b/a SouthWest TeleConnect respectfully request that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation.

## III. STANDARD FOR REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

Section 252(e) of the Federal Act:

- (e) Approval by State Commission
  - (1) Approval Required. Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted to shall approve or reject the agreement, with written findings as to any deficiencies.
  - (2) Grounds for Rejection. The State commission may only reject-
    - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that-
      - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement, or
      - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity; or

The Joint Applicants state that the agreement is consistent with the public interest, convenience and necessity in that it allows for full and fair competition and greater choice for the consumer. The Joint Applicants further state that the Agreement does not discriminate against other carriers not a party to the Agreement as the terms of the Agreement are equally available to any other carrier.

#### IV. MISSOURI LEGISLATION

The negotiated and executed Agreement is consistent with the Missouri Legislation, Senate Bill No. 507, which became effective on August 28, 1996.


WHEREFORE, for the foregoing reasons, Joint Applicants pray that the Commission approve the Agreement expeditiously.
