JOINT FILING FOR REQUESTED TIMELINE

COMES NOW Staff (Staff) of the Missouri Public Service Commission (Commission) and Kansas City Power and Light (KCPL), by and through counsel, and submits their proposed revised timeline for Data Request 0631.

1. KCPL will provide Staff with a "black-lined" version of the redactions of invoices requested through Data Request 0631 by Monday November 16, 2009.
2. On November 20, 2009, Staff will file a pleading outlining, with particularity, the invoice numbers and the page and line numbers of redactions in the documents that remain in dispute, as required by the Order Directing Filing issued November 2, 2009.
3. On November 30, 2009, KCPL will respond to Staff's challenged documents in Data Request 0631 by providing the regulatory law judge a copy of the pages of the invoices identified, with particularity, by the Staff. The copies shall highlight the redacted portions so that the redacted material is visible to the Commission. These documents shall not be filed in the docket and shall be designated highly confidential, as required by the Order Directing Filing issued on November 2, 2009.

WHEREFORE, Staff and KCPL respectfully submit their timeline for addressing Data Request 0631.
