statements of position. These supplements or amendments will conclude with the filing of the Final Decision Point List and Final Offers (the "Final DPL") on April 7, 2006.

3. The Parties respectfully reserve the right to present evidence and argument in support of their interests, whether in conformity with the Joint DPLs attached hereto or not.
