JOINT MOTION FOR EXTENSION

COME NOW, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) and the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”) (hereinafter referred to collectively as “Movants”), by and through their respective counsel, and for their *Joint Motion for Extension* (“Motion”), respectfully state as follows:

1. On June 9, 2021, the Commission issued its *Report and Order Approving Third Addendum to Territorial Agreement* (“Report and Order”).
2. On June 23, 2021, Evergy Missouri West filed a tariff revision (“Compliance Tariff”)¹ pursuant to the Commission’s Report and Order.
3. Also on June 23, 2021, the Commission issued its *Order Directing Staff Recommendation*, which set a deadline of July 9, 2021 for Staff (or any other party) to file their recommendation regarding the Compliance Tariff.
4. Evergy Missouri West plans to substitute its Compliance Tariff and request that the Commission issue an order extending the due date for Staff’s recommendation from July 9, 2021 to July 19, 2021.
