5. In order to continue settlement discussions, the Parties now request until Thursday, May 9, 2013 to file their Surrebuttal and Cross-Surrebuttal Testimony.

6. In addition, the Parties request the following discovery dates established by Commission Orders dated January 17 and March 4, 2013 be modified as outlined below:
