JOINT FILING CONCERNING NEED FOR HEARING

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) and the Office of the Public Counsel (OPC), and states as follows:

1. As a result of discussions with OPC, Ameren Missouri has agreed to resume taking reservation requests for its natural gas energy efficiency rebate program.
2. In light of this agreement, OPC withdraws its request for expedited treatment of this matter and its request for a hearing on December 6, 2010.
3. Ameren Missouri and OPC believe this agreement resolves the issues the Commission had noticed for discussion at its Agenda on December 1, 2010.
4. Ameren Missouri and OPC request the Commission leave open the case until subsequent Collaborative discussions are held regarding details of the relevant tariff.

WHEREFORE, Ameren Missouri and OPC ask the Commission to consider this agreement and issue such orders as it believes are just and reasonable.
