ORDER OPENING AN INVESTIGATION

On April 26, 2023, the Commission's Staff filed a motion asking the Commission to open an investigation file regarding a natural gas incident that occurred on March 11, 2022 on Millers Court in O'Fallon, Missouri. Staff attached its initial incident report to its motion. Staff states that the incident occurred when JDK Cable Contractors were performing work on behalf of Gateway Infrastructure, LLC, and struck Spire Missouri Inc.'s natural gas main, resulting in an explosion and fire that damaged multiple residences. Staff asks the Commission to open an investigation file to receive its initial report and direct responses to the initial report.

The Commission will open this file to facilitate the investigation and receive responses to Staff's report. In addition, an open file will afford Staff an opportunity to report to the Commission as appropriate.

THE COMMISSION ORDERS THAT:

1. The Commission accepts Staff's initial report and opens this file for the receipt of additional reports and responses.

2. Spire Missouri Inc. shall file a response to Staff's initial report no later than May 30, 2023.

3. Any other responses to Staff's initial report shall be filed no later than May 30, 2023.

4. This order shall be effective when issued.
