ORDER SUSPENDING TARIFF, DIRECTING NOTICE AND SETTING
INTERVENTION DATE

On November 30, 2007, Union Electric Company, d/b/a AmerenUE, filed a petition with the Missouri Public Service Commission pursuant to Sections 393.1009, 393.1012 and 393.1015, RSMo Supp. 2006; and 4 CSR 240-2.060, 4 CSR 240-2.080, and 4 CSR 240-3.265. AmerenUE requests adjustment to its rates and charges through the establishment of an Infrastructure System Replacement Surcharge ("ISRS") rate schedule to recover costs for infrastructure system replacement and relocations eligible for ISRS recognition. Section 393.1015.2(3), RSMo Supp. 2006, requires the Commission to act on AmerenUE's application no later 120 days after it was filed. Consequently, the Commission must issue a decision regarding the petition effective no later than March 29, 2008.

With its application, AmerenUE filed a tariff that would implement the surcharge effective January 1, 2008. The Commission will suspend that tariff until March 29, to allow sufficient time to review AmerenUE's ISRS application.

Section 393.1015.1(2) requires the Commission to publish notice of AmerenUE's filing. Therefore, the Commission will give notice of this application to the public and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

IT IS ORDERED THAT:

1. The tariff sheet filed by Union Electric Company, d/b/a AmerenUE on November 30, 2007, and assigned tariff number YG-2008-0354, is suspended until March 29, 2008. The tariff suspended is:

2. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in AmerenUE's service area. In addition, the Data Center shall mail a copy of this notice to each party in GR-2007-0003, AmerenUE's last general rate case for natural gas service.

3. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving AmerenUE's service area and to the members of the General Assembly representing AmerenUE's service area.

4. Any person wishing to intervene in this matter shall file an application to do so no later than December 24, 2007. Such application shall be filed with:
