ORDER APPROVING TARIFF

Issue Date: September 13, 2010

Effective Date: September 15, 2010

On September 1¹, the Commission issued an Order Approving Stipulation and Agreement ("Stipulation"). In that order, the Commission directed Missouri Gas Energy to file tariffs as contemplated by the Stipulation. MGE filed those tariffs on September 8, with substitute tariff sheets filed on September 10; the tariffs bear an effective date of September 15, as the signatories to the Stipulation agreed MGE could file.

The Commission ordered Staff to file a Recommendation, and Staff filed its Recommendation on September 13. Staff stated that the tariff sheets comply with the Commission's Order Approving Stipulation and Agreement, and Staff recommends that the Commission approve them. Although the Commission gave other parties an opportunity to object, no other party objected to the tariffs.

The Commission has reviewed the parties' pleadings and the tariffs. The Commission independently finds and concludes that the tariff sheets will result in just and reasonable rates. The Commission will approve the tariff sheets.

Further, Section 393.140(11) states that the Commission, for good cause shown, may allow tariff sheets to become effective on less than 30 days' notice. The Commission finds good cause exists as stated in its Order Approving Stipulation and Agreement.
