ORDER SETTING DEADLINES

On May 25, 2017, Laclede Gas Company ("Laclede") submitted a revised Tariff Sheet No. R-13 ("Revised Reconnection Tariff") with a June 25 effective date. Concurrent with that submission, Laclede also filed a Motion for Expedited Treatment requesting a June 14 effective date for the Revised Reconnection Tariff. Laclede states that due to flooding, approximately 600 customers lost natural gas service, and approximately 110 customers remain out of service. Laclede's Revised Reconnection Tariff seeks to clarify that neither a service initiation fee nor a reconnection charge will apply to customers who lost service due to flooding in the months of April and May 2017.

The Commission will set a deadline for the Commission's Staff to file a recommendation on the Revised Reconnection Tariff. A deadline will also be set for the filing of objections to Laclede's motion for expedited treatment.

THE COMMISSION ORDERS THAT:

1. No later than May 31, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation on Laclede's Revised Reconnection Tariff.

2. Responses to the Staff filing directed in Paragraph 1 of this Order shall be filed no later than June 2, 2017.

3. No later than June 2, 2017, objections may be filed to Laclede's Motion for Expedited Treatment.

4. This order shall be effective when issued.
