NOTICE OF WITHDRAWAL

LCR Telecommunications, LLC ("Applicant"), a Michigan Limited Liability Company, respectfully requests that the Missouri Public Service Commission ("Commission") withdraw without prejudice its application for a Certificate of Service Authority to Provide Interexchange Telecommunications Services and to Classify such Services and the Company as Competitive in accordance with 4 CSR 240-2.116(1). Applicant filed this application with the Commission on March 7, 2002. On March 18, 2002, the Office of Public Counsel filed a Request for Evidentiary Hearing. On April 4, 2002, the Staff of the Missouri Public Service Commission filed its recommendation, recommending that the Commission deny Public Counsel's request for an evidentiary hearing and instead approve the application.

Public Counsel filed a Reply on April 5, 2002, indicating that an evidentiary hearing and investigation into the Applicant be mandated. On April 19, 2002, the Commission issued an Order Suspending Tariff, Directing Notice, and Directing Filing. LCR Telecommunications, LLC filed its response to the Commission order on May 10, 2002. On May 16, 2002, the Commission ordered that the Staff of the Commission and

the Office of the Public Counsel file their responses to LCR Telecommunications, LLC's May 10, 2002 pleading.

The Office of Public Counsel filed its Reply to Company's Response on May 16, 2002, renewing its request for an evidentiary hearing. Staff of the Missouri Public Service Commission filed its Staff Response to LCR Telecommunications, Inc.'s Response on May 22, 2002. Again, Staff recommended that the Commission deny the Office of Public Counsel's Request for Evidentiary Hearing.

On June 1, 2002, the Commission filed an Order Setting Prehearing Conference and Directing Filing of Procedural Schedule. Such Prehearing Conference took place on June 17, 2002.


