On July 21, 2020, the Staff of the Missouri Public Service Commission (Staff) requested the Commission open a file for investigation of a natural gas pipeline incident in Kansas City, Missouri. On June 30, 2021, Staff filed its report.

On July 12, 2021, Spire Missouri Inc. filed its *Request for Additional Time to Respond to Staff's Gas Incident Report*. In its filing, Spire Missouri requests until September 13, 2021, to respond to Staff's report.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Spire Missouri, Inc. shall file its response to Staff's Gas Incident Report on or before September 13, 2021.
2. This order shall be effective when issued.
