ORDER DIRECTING ADDITIONAL REPORT

On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. The Commission ordered its Staff to file progress reports regarding its investigation. Staff timely filed progress reports on February 28, 2022, June 23, 2022, October 27, 2022, and April 27, 2023.

In its fourth progress report, on April 27, 2023, Staff explains that its investigation is proceeding and asks that it be directed to file either a report regarding its investigation, or a further progress report by no later than July 12, 2023. The Commission will order Staff to file a further report.

THE COMMISSION ORDERS THAT:

1. Staff shall file either a report regarding its investigation, or a report on the investigation's progress, no later than July 12, 2023.
2. This order shall be effective when issued.
