STAFF’S REVISED REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Staff Report in Case No. GT-2009-0413 and the related Tariff Filing No. JG-2009-0813 states as follows:

1. On May 15, 2009, Union Electric Company, d/b/a AmerenUE (AmerenUE) filed a petition with the Missouri Public Service Commission (Commission) to change its Infrastructure System Replacement Surcharge (ISRS), pursuant to RSMo¹ Sections 393.1009, 393.1012 and 393.1015.

2. On July 14, 2009, Staff filed its Recommendation, which included, as Appendix B, a table of the rates resultant from Staff’s revenue requirement calculation in the current and prior ISRS cases of \$2,579,277.

3. Following its review of Staff’s recommendation, AmerenUE supplied additional information that resulted in Staff making changes to its revenue requirement calculation.

4. The revised “incremental” revenue requirement applicable to this filing is \$1,022,171.

5. Please find, attached, Revised Appendix B, a revised table of rates based on Staff's revised composite revenue requirement of \$2,624,439.

WHEREFORE, Staff respectfully requests that the Commission accept these Revisions to Staff's Report, and recommends the Commission issue an Order (1) rejecting AmerenUE's ISRS tariff sheet (JG-2009-0813), (2) approving Staff's determination of the incremental ISRS surcharge revenues in the amount of pre-tax revenues of \$1,022,171, and (3) authorizing AmerenUE to file an ISRS rate for each class of customers as reflected in the attached Appendix B. These rates produce \$2,624,439 annually and correspond to the cumulative revenue requirements for the three (3) ISRS filings approved by the Commission and presently in effect.
