ORDER GRANTING EXPEDITED TREATMENT AND APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: August 26, 2009

Effective Date: September 1, 2009

In its Order Approving ISRS Rates and Rejecting Tariff, issued on August 12, 2009, the Commission authorized Union Electric Company, d/b/a AmerenUE, to file a tariff changing its Infrastructure System Replacement Surcharge (ISRS) sufficient to recover incremental ISRS surcharge revenues of \$1,022,171 as shown in the attachment to Staff's Revised Report filed July 30, 2009. That rate produces \$2,624,439 annually and corresponds to the cumulative revenue requirements for the three ISRS filings approved by the Commission and presently effective.

AmerenUE filed the required tariff on August 13, 2009, with an effective date of September 12, 2009. Along with its tariff, AmerenUE filed a motion for expedited treatment asking the Commission to approve the tariff to become effective on September 1, 2009.

Staff filed its recommendation regarding the tariff on August 25, 2009. Staff indicates that the tariff complies with the Commission's order, and recommends the

Commission approve the tariff to become effective on September 1, 2009. No other party has filed a recommendation or a response to the motion for expedited treatment.

Based on Staff's recommendation, the Commission determines the tariff complies with the Commission's order. Because the Commission has previously approved these rates, the Commission also finds good cause to approve the tariff to be effective in less than 30 days. The tariff is approved to become effective September 1, 2009.

THE COMMISSION ORDERS THAT:

1. Tariff No. YG-2010-0086, filed on August 13, 2009, by Union Electric Company, d/b/a AmerenUE, is approved to become effective on September 1, 2009. The tariff sheet approved is:
