1. On June 19, 2009, the Commission Staff (“Staff”) filed its “Preliminary Report of the Staff Respecting Its Construction Audit /Prudence Review of Environmental Upgrades to Iatan 1 and Iatan Common Plant as Directed in the Missouri Public Service Commission’s April 15, 2009 Orders Regarding Construction Audits And Prudence Reviews and Modified in the June 10, 2009 Orders Regarding Joint Motion to Extend Filing Dates in Case Nos.
