MOTION FOR EXPEDITED TREATMENT

Comes Now Kingdom Telephone Company d/b/a Kingdom Long Distance ("Kingdom Long Distance") and for its Motion for Expedited Treatment states to the Missouri Public Service Commission ("Commission") as follows:

1. On August 29, 2003, counsel for Kingdom Long Distance prepared for filing with the Commission four tariff revisions designed to allow Kingdom Long Distance and Kingdom Telephone to offer a new service called "MTS 1 Plus Optional Calling Plan" for residential subscribers. One tariff revision was filed on behalf of Oregon Farmers Mutual Telephone Company to introduce a new High Capacity Special Access Service. One tariff revision was filed on behalf of Kingdom Telephone Company to introduce a new High Capacity Special Access Service. Another tariff revision was filed on behalf of Kingdom Telephone Company to introduce a new Residential and Business Service Bundles for the company's subscribers. All of these tariffs bore an effective date of October 1, 2003.


2. On this date, while checking the status of these tariff filings, counsel for Kingdom Long Distance discovered that the filing for Kingdom Long Distance had not been received by the Commission. The other three tariffs are listed as approved in the Commission's EFIS system.

3. Pursuant to Commission Rule 4 CSR 240-2.080(16), Kingdom Long Distance requests that the Commission grant expedited treatment to this tariff filing in order that this tariff may become effective on October 1, 2003, as was contemplated by Kingdom Long Distance when the original tariff filings were prepared. These tariff filings are interrelated as neither Kingdom Telephone or Kingdom Long Distance will be able to offer the bundled services approved in the other tariffs unless the current filing is also effective by October 1.

4. Customers of both Kingdom Telephone and Kingdom Long Distance will benefit from this new service offering. This pleading was filed as soon as possible after it was discovered that the tariff had not been properly filed.

Wherefore Kingdom Long Distance respectfully requests that the Commission grant its Motion for Expedited Treatment and approve the tariff filing filed with this pleading.


