**ORDER DIRECTING STAFF REPLY ON UNAVOIDABLE
TRANSPORTATION COMMODITY CHARGES**

Summit Natural Gas of Missouri, Inc. ("Summit" or "Company") submitted a Response to the Recommendation filed by the Commission's Staff concerning the Company's 2014-2015 Actual Cost Adjustment. Summit does not dispute its responsibility for avoidable Authorized Overrun Charges ("ORA"), as referenced by Staff in its Recommendation. However, Summit states that Staff's recommended \$15,327 adjustment to ORA includes imbedded transportation commodity charges that are unavoidable. Summit states that the unavoidable charges total \$2,040. Recognizing that amount, Summit accepts a disallowance in avoidable ORA of \$13,287, rather than the \$15,327 recommended by Staff.

The Commission will direct Staff to submit a reply to Summit's Response that identifies any disagreement it may have with Summit's recommended ORA total.

THE COMMISSION ORDERS THAT:

1. No later than February 3, 2017, Staff shall file a reply to Summit's Response to Staff Recommendation and Memorandum.

2. This order shall be effective when issued.
