MOTION TO SUPPLEMENT APPLICATION

Tennessee Telephone Service, LLC dba Freedom Communications USA, LLC ("Applicant"), a Delaware Corporation, hereby moves to supplement its Application for Certification and to add material concerning its technical expertise as a provider of basic local telecommunications services, to demonstrate its compliance with Ch. 392.455(1), RSMo., and 4 CSR 240-3.510(1)(D)(1). In support of this Motion, the Applicant states the following:

1. The Applicant filed its Application on September 28, 2009, and supplemented the Application on November 4, 2009 and January 19, 2010.

2. Two of the Applicant's management employees, customer service manager (Jeannie Hutchison) and operations manager (Carol Proctor), who have both been employed by the Applicant for seven years, have extensive experience working with AT&T and other ILECs in provisioning orders and servicing customers. Ms. Hutchison routinely deals with customer problems and is responsible for crafting solutions to meet issues raised by customers with respect to their local exchange and interexchange telecommunications needs. Ms. Proctor deals directly with peer-level employees at AT&T and other ILECs from which the Applicant purchases UNEs and access lines, troubleshooting vendor relations issues as they arise. Both employees are instrumental to the Applicant's ability to order, provision, and respond to customer needs.

Wherefore, the Applicant moves to supplement its Application with the material provided in paragraph 2 hereof, and requests that the Commission and Staff consider this supplemental information in their review of the Application.
