APPLICATION FOR CHANGE OF ELECTRIC SERVICE PROVIDER

1. Applicant's address is: 19106 US Highway 61 North; Sikeston, MO 63801.
2. The name of Applicant's current electric service provider is: SEMO Electric Cooperative; 1505 South Main Street; Sikeston, MO 63801.
3. Applicant requests the Missouri Public Service Commission to order a change of electric supplier to the address indicated above.
4. Applicant requested the Commission to order a change of electric supplier from SEMO Electric Cooperative
(Current)
to Sikeston Board of Municipal Utilities
(Requested)
5. Applicant requests the Missouri Public Service Commission to order a change of electric provider for the following reasons. *The Applicant's residence is located in an area that was formerly outside the city limits of Sikeston, MO. The area has now been annexed into the city for future development. Applicant requests the change in service on the basis that, as a resident of the City of Sikeston, he will experience an unjust disparity in his electric service rate since all new customers in the annexed area surrounding the Applicant's residence will be served by the Sikeston Board of Municipal Utilities at lower rates than currently charged by the SEMO Electric Cooperative. Applicant also advises

that the Sikeston Board of Municipal Utilities provides electric service to grain storage facilities owned by the Applicant, located within the Sikeston city limits and adjacent to Applicant's residence. The Applicant is desirous of having one electric service provider rather than two.

6. Applicant has taken the following steps in an attempt to work out electric service problems with the electric service provider: N/A. There are no service problems at issue in this case.

WHEREFORE, Applicant requests the Missouri Public Service Commission to issue an Order which changes the current electric service provider.
