**MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE
AUTHORITY AND ACCOMPANYING TARIFFS**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificates of Service Authority and Accompanying Tariffs, respectfully states as follows:

1. The above-captioned companies have been granted certificates of service authority by the Missouri Public Service Commission (Commission) pursuant to the Commission's authority under Section 386.250 RSMo 2000. Each of the above-captioned telecommunications companies (hereinafter referred to as the "Companies") is listed on Attachment 1 (incorporated by reference herein and for all further references). Attachment 1 is prepared and verified by affiant Staff employee Sherri L. Kohly of the Utility Operations Division. Attachment 1 contains the following information for each of the above-referenced Companies:

- a) certificated company name and last current address,
- b) case number and date of certification,
- c) type(s) of certificate of service authority granted by the Commission,
- d) tariff number(s) to be cancelled, if any, and
- e) date of dissolution by the Office of the Secretary of State.

2. Each of the Companies, as further referenced in Attachment 1, share the following common facts that apply to each company and support Staff's motion to open a mass docket case for the cancellation of the Companies' certificates and tariffs:

- a) Staff is unable to contact the company through a valid mailing address or telephone number.
- b) The company's 2002 annual report form was returned by the post office as undeliverable and is therefore delinquent. Telecommunications companies are

required to file a Missouri-specific annual report pursuant to Sections 392.210 and 392.390.1 RSMo 2000. Indeed, all mail sent by the Staff to each company is returned by the postal service.

- c) The company is "dissolved" according to the office of the Missouri Secretary of State. See Attachment 1 for date of dissolution. Section 351.476(1) states "A dissolved corporation continues its corporate existence but *may not carry on any business except that appropriate to wind up and liquidate its business and affairs...*"

3. The inability of Staff to contact the Companies through a valid mailing address and the failure of the Companies to submit a 2002 annual report and the "dissolved status" of the Companies, form the basis for Staff's motion to open case. Staff believes that the Companies have violated the terms of their certificates of service authority by 1) their failure to keep the Commission informed of a current address and telephone number, and 2) by the failure of the Companies to file a 2002 annual report. Section 392.210(2) states, among other things, "The commission shall at all times have access to all accounts, records and memoranda kept by telecommunications companies..." Because the Companies have failed to keep the Commission informed of a current address or telephone number, the Commission is unable to contact the Companies. Therefore, the Companies have denied the Commission the access that is required of the Commission under Section 392.210(2). Indeed, the Companies have denied the Commission its ability to supervise telecommunications operations and services as statutorily mandated under Section 386.250.

4. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5 RSMo 2000, which provides:

"Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application

of the person or company affected.”

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

5. Because the Companies have provided no current contact information and because the 2002 annual report and all other mail is returned to the Commission by the United States Postal Service as undeliverable, Staff is unable to provide service of this pleading to the Companies directly. Therefore, the Staff is serving this pleading on the registered agent for each company as listed on the website of the Secretary of State. If the Secretary of State’s office reports no registered agent, Staff is serving this pleading on the last known principal office address of the company as reported by the Secretary of State. Section 351.380(1) RSMo 2000 provides:

“The registered agent so appointed by a corporation upon whom any process, notice or demand required or permitted by law to be served upon a corporation may be served.”

Commission Rule 4 CSR 240-2.080(17)(C)(1) states “Service by mail is complete upon mailing.”

WHEREFORE, the Staff recommends the Commission issue an order canceling the certificates of service authority and the accompanying tariffs of the above-captioned Companies as indicated on the verified attachment (Attachment 1) submitted by Staff.

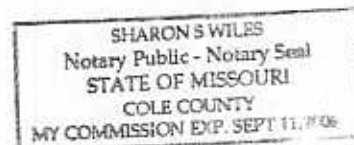
