ORDER APPROVING INTERIM RATES

Issue Date: September 30, 2009 Effective Date: October 1, 2009

On September 15, 2009, Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas filed a revised tariff sheet with a proposed effective date of October 1, 2009. The tariff sheet reflects changes to the purchased gas adjustment (PGA) factor resulting from estimated changes in the cost of natural gas.

The net effect of this change will decrease the total PGA factor from the current \$0.7500 to \$0.7200 per hundred cubic feet (Ccf). Additionally, the Actual Cost Adjustment will decrease from the current \$0.0411 to \$0.035. These changes are expected to result in a decrease of \$18.00 or 2.3% annually from current levels for the typical residential customer.

On September 28, the Staff of the Commission filed its recommendation. Staff states that Southern Missouri has calculated the rates in conformance with the company's PGA clause except for the approach used to calculate interest. In this regard, Staff has notified the company to continue calculating interest based on the ACA method and has requested that the company file a revised tariff sheet number 22 after the proposed sheet

goes into effect. Finally, Staff recommends that the Commission approve the proposed interim tariff sheet revision, subject to refund.

Having reviewed the proposed revised tariff sheet and Staff's recommendation, the Commission finds that the proposed tariff revisions were calculated in conformance with the company's Commission-approved PGA clause and will approve the sheet to go into effect on October 1.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on September 15, 2009, by Southern Missouri Gas Company, L.P. is approved on an interim basis, subject to refund, for service rendered on and after October 1, 2009. The tariff sheet approved is:
