REPORT OF CENTURYTEL OF MISSOURI, LLC

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel") and, pursuant to the Missouri Public Service Commission's ("Commission") <u>Order Overturning North American Numbering Plan Administrator's Decision</u> ("Order") issued in this matter on December 19, 2006, respectfully files its Report with the Commission recommending that this case now be closed.

- 1. As a part of the Commission's Order overturning the North American Numbering Plan Administrator's decision to withhold numbering resources from CenturyTel, the following Ordered Paragraphs provided as follows:
 - 1. The North American Numbering Plan Administrator's decision to withhold numbering resources from CenturyTel of Misssouri, LLC is overturned.
 - 2. CenturyTel's request to receive one new NXX code with one block of 1,000 numbers for each of the following CenturyTel rate centers necessary for implementation of the new Tier 6 of the St. Louis Metropolitan Calling Area (MCA) Plan: Foley, Holstein and Wright City, Missouri, is granted.
 - 3. Within 30 days of receiving the three 10,000 NPA/NXX codes, CenturyTel shall return to the Pooling Administrator, 9,000 telephone numbers in each of the three 10,000 NPA/NXX codes issued for the Foley, Holstein, and Wright City rate centers, and submit a pleading in this case informing that the numbers have

been returned, and include a copy of the Pooling Administrator Part 3 form verifying return of the unused telephone numbers. (Order at 3).

- 2. As reflected in the attached "Pooling Administrator's Response/Confirmation Part 3" forms ("Attachment A"), CenturyTel was issued 1,000 numbers (rather than 10,000) on January 15, 2007, to be effective March 1, 2007, in each of the subject rate centers. Rather than the whole NXX, the Pooling Administrator only assigned three separate 1,000 blocks (this is represented by the "NPA-NXX-X 636-791-2 (Wright City), NPA-NXX-X 636-782-2 (Holstein) and NPA-NXX-X 636-355-2 (Foley)" designations on the attached forms).
- 3. Accordingly, CenturyTel did not have to return the anticipated 9,000 telephone numbers in each of the three codes as required in Ordered Paragraph 3 above.
- 4. CenturyTel submits this pleading within 30 days of receiving the telephone numbers, in compliance with Ordered Paragraph 3 of the Order.
- 5. Whereas all actions contemplated by the Commission's Order have occurred, CenturyTel respectfully submits that this case may now be closed.

WHEREFORE, CenturyTel respectfully submits its pleading informing the Commission of the above-stated actions and the current status of this matter.
