On June 2, 2006, Trigen-Kansas City Energy Corporation (Trigen or Company) of Kansas City, Missouri, filed with the Commission three (3) tariff sheets with a proposed effective date of July 2, 2006 to revise the Company's territorial description and map approved by the Commission in its REPORT AND ORDER Issued May 25, 2006, effective June 1, 2006. On June 6, 2006, Trigen filed a substitute tariff sheet to make correct, the reference to the map as requested by the Missouri Public Service Commission Energy Department Staff (Staff).

In its REPORT AND ORDER Issued May 25, 2006, the Commission Ordered 2.:

Trigen-Kansas City Energy Corporation is granted a Certificate of Convenience and Necessity authorizing it to construct, install, own, operate, control, manage and maintain a steam heat distribution system to provide steam heat service in Kansas City, Missouri, as an expansion of its existing certified area more particularly described in Exhibit 8 (Appendix A to the application) presented at the hearing.

The Staff has reviewed the filed tariff sheets, and is of the opinion that they were filed in a timely manner and are in compliance with the Commission's Order. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on June 2, 2006, and substituted on June 6, 2006, to become effective on July 2, 2006, as requested in Trigen's cover letter:

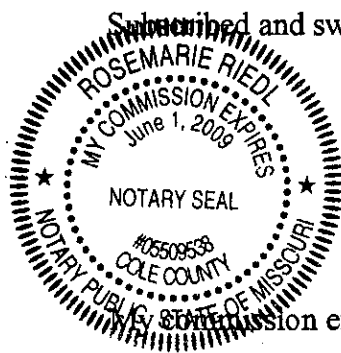
