

These revisions are filed in accordance with Missouri Public Service Commission Rules and Regulations and submitted with an October 31, 2003 issue date and a proposed effective date of December 18, 2003. The purpose of this filing is to modify rates in accordance with Sprint's Price Cap regulation, pursuant to Section 392.245, RSMo 2000. Within this filing, Sprint is adjusting its basic rates by the change in the CPI-TS as required by 392.245.4(a) updating its maximum allowable prices for non-basic services and adjusting certain rates as allowed by 392.245.11; and adjusting certain switched access rates as allowed by 392.245.9.

All affected customers will receive thirty (30) days advance notification of these changes, as previously communicated to the commission's staff. A summary of the rate adjustments and supporting calculations have been provided to Mr. William Voight under separate cover.

## II. General Regulations (Cont'd)

- D. INFO-LINK is designed only to provide local one-way dialing to the Internet. This service is restricted to the transfer of electronic data. Voice traffic in conjunction with this service is prohibited.
- E. Unless otherwise specified, INFO-LINK is subject to the Rules and Regulations applying to all customer contracts as specified in the General Exchange Tariff of the Telephone Company.
- F. The minimum service period for subscription to INFO-LINK is one month and is billed one month in advance.
- G. INFO-LINK rates are incremental to charges paid by the customer for other services of the Telephone Company. Rates are on a per-line basis. This service can be used only in conjunction with Touch Tone Service and One-Party or Trunk Local Exchange Service.
- H. INFO-LINK charges will be developed on an individual case basis (ICB) when used in conjunction with Centrex service. Charges for the services offered on an ICB basis will be structured to recover the company's cost of providing the service. Terms of specific ICBs will be made available to the Missouri Public Service Commission Staff upon request on a proprietary basis.
- I. INFO-LINK will not be offered in conjunction with any Local Measured Service.

1+710 Government Emergency Telecommunications Service Calls will not be blocked in the central office and will be completed.

Lifeline subscribers may receive Toll Restriction Service without paying a monthly or non-recurring charge.

Restriction of access to operator services prevents the customer from dialing an operator for all purposes including emergencies, assistance and the placing of toll calls. The customer indemnifies and saves harmless the Telephone Company from any and all claims, losses or damages caused by restriction of access to operator services.

## F. BILLED NUMBER SCREENING

## 1. General

Billed Number Screening is a service which through operator screening prevents the receipt of incoming collect and/or third number billed calls from being billed to the customer. The customer's telephone number is included in the data base that is made available to companies which provide validation services. Inclusion in the data base indicates these calls will not be allowed for billing to the customer's line. The customer benefits from Billed Number Screening as the service eliminates nuisance third party calls and blocks the receipt of collect calls.

Operator screening of incoming collect, international collect and third number billed calls is limited to Local Exchange Companies or Carriers which access the validation data base and cannot be guaranteed. Therefore, charges for any such calls received from a Local Exchange Company or Carrier not accessing the validation data base will be the responsibility of the customer.

Billed Number Screening is available to all classes of service which utilize the public switched network for long distance calling. The monthly recurring rate is not applicable for Payphone Line Service.

## 2. Rates and Charges

A Service Order Charge as specified in Section 30 of this Tariff is applicable per main billing number when this service is installed or changed subsequent to the service with which it is associated or for any change in options. The Service Order Charge is not applicable for termination of the service.
