**JOINT MOTION FOR EXTENSION OF TIME**

Transource Missouri, LLC (“Transource Missouri”), Kansas City Power & Light Company (“KCP&L”), KCP&L Greater Missouri Operations Company (“GMO”), the Staff of the Missouri Public Service Commission (“Staff”), and the Office of the Public Counsel (“OPC”) (collectively, “Movants” or “Parties”) file this Joint Motion for an Extension of Time. In support thereof, the Movants state as follows:

1. On May 7, 2013 the Missouri Public Service Commission (“Commission”) issued its Order Amending Procedural Schedule, in which it ordered the Parties to address the Commission’s inquiries as to the pending Stipulation and Agreement (“Stipulation”) by filing a memorandum in support of that Stipulation, and a proposed report and order approving that Stipulation by May 30, 2013. The Commission’s Order Amending Procedural Schedule adopted the Parties’ proposed amended procedural schedule filed on May 6, 2013, in which the Parties recommended the May 30<sup>th</sup> deadline.

2. The Movants have been diligently working on drafts of a Joint Memorandum in Support of the Stipulation that responds to the Commission’s April 29, 2013 Order to File Proposed Amended Procedural Schedule and the detailed inquiries set forth in the Appendix to

such Order. They have also drafted and are exchanging language on a Proposed Report and Order that approves the Stipulation. Despite these diligent and cooperative efforts, additional work remains to be done on both the Joint Memorandum and the Proposed Report and Order. Moreover, GMO and OPC also have had multiple briefs and other pleadings due at the Missouri Court of Appeals in several appellate cases over the course of the past few weeks. Also in the past few weeks, Staff, OPC, KCP&L and GMO have negotiated, drafted, and filed Stipulation and Agreements in File Nos. EO-2012-0135 and EO-2012-0136, the cases respecting KCP&L and GMO seeking Commission authorization to extend the transfer of functional control of certain transmission assets to the Southwest Power Pool.

3. Consequently, the Movants request an extension until Friday, June 7, 2013 to submit the filings noted in the Commission's Order Amending Procedural Schedule. Should they complete their work on either the Joint Memorandum in Support of the Stipulation or the Proposed Report and Order prior to June 7, the Movants intend to make such filing before then.

WHEREFORE Transource Missouri, LLC, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, the Staff of the Missouri Public Service Commission, and the Office of the Public Counsel respectfully request that the Commission extend the time for the filing of a memorandum in support of the Stipulation and a proposed report and order approving that Stipulation from May 30, 2013 to June 7, 2013.
