## **JOINT MOTION TO REVISE EXISTING BRIEFING SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), on behalf of itself and the parties to this proceeding, including Lake Region Water and Sewer Company, Office of Public Counsel, Four Seasons Racquet and Club Condo Property Owners Association Inc., and Four Seasons Lakesites Property Owners Association, Inc. and respectfully states as follows:

1. On November 17, 2009, the Commission issued an *Order Adopting Procedural Schedule*.
2. On April 8, 2010 the Commission issued an *Order Directing Discovery and Directing Filing*. This Order directed Staff to conduct additional discovery on the issue of availability fees. Since discovery is still being conducted, the issue is not ripe to brief. Parties propose the following change to the briefing schedule:
