PROPOSED PROCEDURAL SCHEDULE

COMES NOW Spire Missouri Inc. (“Spire”), the Staff of the Missouri Public Service Commission (“Staff”), and the Missouri Office of the Public Counsel (“OPC”) collectively referred to as (“the Parties”) and hereby submits this Proposed Procedural Schedule, and in support thereof respectfully states as follows:

1. On March 19, 2020, the Missouri Public Service Commission (“Commission”) issued its *Order Requiring Filing* (“Order”), in which it directed the Parties to submit a proposed procedural schedule to include proposed dates for an evidentiary hearing; deadlines for all filings including testimony, exhibits, issue statements, position statements and briefs; and addressing all other procedural concerns as deemed necessary by the Parties.

2. In response to the Commission’s Order, the Parties have conferred and agreed to a proposed procedural schedule for both of the underlying cases as follows:

April 10, 2020	Spire Response to Recommendations
April 17, 2020	Simultaneous direct testimony – all parties
April 21, 2020	List of Issues, list and order of witnesses, order of cross-examination, order of opening statements – no later than 5:00 p.m.
April 22, 2020	Position Statements – no later than 12:00 p.m.
April 23-24, 2020	Evidentiary Hearing
April 29, 2020	Expedited Transcripts
May 5, 2020	Simultaneous post-hearing briefs
