



Missouri's representations, it does not object to the request for additional time to respond. No other response was received.

Commission Rule 4 CSR 240-2.090(2)(C) states that answers to data requests shall be made within 20 days of receipt unless "otherwise ordered by the commission." Although Ameren Missouri stated it requests a "variance" from the rule, it is essentially asking for additional time to file its responses to the data requests, which is allowed under the rule if ordered by the Commission. The Commission determines that Ameren Missouri has good cause for delaying its response to the data requests posed by Staff with regard to the documentation of all natural gas purchases in this 2017-2018 ACA filing and will grant the requested extension.

**THE COMMISSION ORDERS THAT:**

1. Union Electric Company d/b/a Ameren Missouri is granted an extension of time until January 31, 2019, to provide answers to data requests posed by the Staff of the Missouri Public Service Commission with regard to the documentation of all natural gas purchases in its 2017-2018 Actual Cost Adjustment filing.
2. This order is effective when issued.
