On December 15, 2021, the Staff of the Commission filed a recommendation and memorandum regarding its review of Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities' 2019-2020 Actual Cost Adjustment (ACA) filing. Staff proposed several financial adjustments to Liberty Utilities' ACA balance, and offered non-financial recommendations regarding several aspects of the company's operations. Staff asks the Commission to direct Liberty Utilities to respond to its recommendations.

The Commission will order Liberty Utilities to respond to Staff's recommendations.

THE COMMISSION ORDERS THAT:

1. Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities shall respond to the recommendations of the Commission's Staff no later than January 14, 2022.
