On November 12, 2021, the Commission issued its *Amended Report and Order*, which included a requirement that Spire Missouri Inc. (Spire) filed periodic status reports regarding certain employee transfers. Spire has subsequently been filing said status reports every 60 days.

On March 17, 2023, Spire filed its most recent status report. In that filing, Spire requested to be relieved of its obligation to file said status reports in this case as Spire has committed to continue quarterly reporting as part of its more recent general rate case, File No. GR-2022-0179.

Commission rules allow parties 10 days to respond to any filing. No objections or responses to Spire's request were received. The Commission finds the unopposed request reasonable and will grant it. Additionally, as no further action is required by the Commission in this matter, it will close this file.

THE COMMISSION ORDERS THAT:

1. Spire's request to be relieved of its obligation in the above captioned matter to file status reports regarding certain employee transfers is granted.
2. This file is closed.
3. This order shall be effective when issued.
